## SFC launch events – latest details

One East Midlands are in the process of organising the free launch events for each of the SFC network launches. The launch dates already set, though the venues are still to be confirmed, are:

- Lincoln - 11 September
- Grantham - 13 September
- Derby - 25 September
- Derbyshire - 27 September.

All of the above launch events will take place from 10am to 12pm. The dates for the launch events in Nottingham, Nottinghamshire and Northamptonshire are yet to be confirmed, but are expected to take place in late September or early October.

Each event will include presentations on SFC, Police and Crime Commissioners (PCCs), the role of the community safety partnership, roundtable discussions on local case studies, and the chance to network with other members of your SFC network. You will also have the opportunity to meet some of your potential PCC candidates.

Full details of the launch events, including dates, times, venues and agendas will be circulated to you as we confirm them. - Any particular aspects of skills developed or learning that you would like to share

## Guide to influencing the PCCs

In the run up to and after the PCC elections many individuals, organisations, public bodies and even private companies will be vying for the PCCs attention. Your case for the PCC to listen to the knowledge and understanding of the VCSE in setting their plan and for the continued funding of VCSE community safety activities will be stronger if you address the PCCs priorities and frame the VCSE work accordingly.

CLINKS, the national charity supporting voluntary organisations working with offenders and their families and the leading national SFC partner, has produced a guide to influencing your PCC and making the case for the VCSE Sector. The guide is in three sections:

- Section 1 looks at things which are likely to be high priorities for every prospective and elected PCC and explores what they mean for the VCSE and what kind of evidence can you use to gain influence in this area.
- Section 2 looks at issues which may not be priorities for the public and which PCC candidates may find be less familiar with and find more challenging but which are important to the VCSE Sector and the communities we represent.
- Section 3 examines who should be the audience for your influencing activities.

## **Free consultancy support**

As part of its Sustainable Work with Offenders Project (SWOP), CLINKS is funding free consultancy support to over 60 small to medium criminal justice organisations who are facing financial challenges and wish to improve their

financial sustainability. As they are currently under-represented in the two regions, the five final offers of this support will be exclusive to organisations based in the East Midlands or the East of England.

To be eligible for support, organisations must be a charity or social enterprise, have an annual income of less than £3million, be members of CLINKS, or be willing to join CLINKS, and have experienced actual or predicted reduction in income from previous sources. You must also be carrying out significant work with offenders or supporting the sustainability of local criminal justice organisations.
